Theoretical Coverage

3 - 4 m2/Kg per coat. Actual coverage will vary depending on substrate porosity.

Packaging

20 and 200 Kg drums.

Shelf Life

12 months when stored between 5 and 40C under shade in a dry environment.

Installation Guidelines Surface Preparation

All surfaces to be treated should be clean and free from any contamination or surface water. Hot and porous substrates should be primed with a primer coat of diluting X-Pruf RBE with 15-20% of potable water. Apply to the substrate and allow to absorb and dry before application of the second coat with diluted percentage of 5-10% with potable water. Normally 2 or 3 coats are required depending on degree of protection required.

Application

X-Pruf RBE Membrane can be applied by brush, squeegee or airless spray. Stir well prior to use. It is recommended that one or two coats should be applied depending on the degree of protection required. Allow a minimum of 3 hours drying time between coats. For vertical applications, ensure that no sagging occurs. For multiple coat applications, the second coat should be applied at right angles to the first. All applications should be continued up verticals to the existing damp proof course. Ensure that the membrane is not damaged during subsequent applications. Where X-Pruf RBE Membrane is to receive a screed, two coats should be applied. The second coat should be blinded with clean, dry sharp sand immediately after application. The excess sand should be brushed off when the coating has dried.

Clean Up

Clean tools and equipment with water while still wet. Once dry, remove mechanically or using a suitable solvent.

Limitations

Do not expose to sunlight for long periods. Do not apply at temperatures below 5C or above 45C. Do not add solvent. Avoid skin contact. Do not discard into the water system.
